## TOWNSHIP HALL OFFICE RENOVATION:

• Trustee Finley reported he has inventoried the files being kept at FO Boles' residence. He plans to take an inventory of the files at the Township office. These inventories will determine how many fire-proof filing cabinets will be needed in the office.

• Document Retention Policy: FO Boles sent copies of the current Township Document Retention Policy to the Trustees. The Trustees agreed to see if this policy needs to be updated.

## MCIMETRO FIBER CONSTRUCTION IN CHAGRIN FALLS TOWNSHIP:

- Trustee Finley reported he received a letter of notice from MCImetro
  Fiber Construction stating they are in the planning stages to construct
  fiber network in/through Chagrin Falls Unincorporated Township. They
  are "reaching out to get details on permitting in Chagrin Falls
  Township for underground construction in the Right-of-Way".
- Concerns were discussed including the fact the Unincorporated portion of the Township is all private property, no public property.
- The Trustees agreed the Cuyahoga County Prosecutor's Office should be contacted for their opinion and advice in this matter. Trustee Finley will send a letter/email.

# **TOWNSHIP ZONING INSPECTOR:**

- Trustee Finley announced Mr. Tom Turner will be stepping down as the Township Zoning Inspector. Mr. Turner and his wife will be moving into the Village of Chagrin Falls.
