The meeting was called to order by Chairperson Tom Florkiewicz, via ZOOM, at 7:00 p.m. Those present included Trustee John Finley; Trustee Jennifer McKee; Township Hall Rental Agent (THRA) Elizabeth MacIver; Township Zoning Inspector (TZI) Edgar Boles and Fiscal Officer (FO) Elizabeth Boles.

EVERGREEN CEMETERY BURIAL RIGHTS OPTION FOR UNINCORPORATED TOWNSHIP (UTWP) RESIDENTS:
